- 4. The college has to develop the requisite infrastructure for IV<sup>th</sup> Professionals well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
