Notification

In continuation of Notification dated 29 Jan, 2009 and dated 13 June, 2015 ;

The Jayoti Vidyapeeth Women's University established and incorporated under the Act 17 of 2008 passed by Rajasthan State Legislature and notified by the Government of Rajasthan through its official Gazette Notification No. F.2 (23) Vidhi /2/2008 dated April 21, 2008.

In exercise of power conferred under section 4 of the University Act, " **University offering Certificate/Diploma/Post Graduate Diploma/Bachelor & Master Degree/Dual Degree/Doctorate Degree/Research Degree**" in the disciplines specified in Schedule II and programs mentioned in State Government special letter dated on 26.12.2014 with prior approval of Statutory Body if any.

The Jayoti Vidyapeeth Women's University is recognized by University Grants Commission (UGC) under Section 2(f) of the UGC Act, 1956 and programs offered by the University are recognized by Statutory Bodies namely, Central Council of Indian Medicine (CCIM), Central Council of Homoeopathy (CCH), Bar Council of India (BCI), Pharmacy Council of India (PCI), National Council For Teacher Education (NCTE) and Distance Education Bureau(DEB) -UGC .

In compliance of Section 5 of "The Jayoti Vidyapeeth Women's University Act 2008" (17 of 2008) " **Power and Function Of the University**", with read under sub- section (q), "To make special arrangements in respect of women students as the University may consider desirable" mentioned as under :

- 1) Female students may enrolled in Regular- General, Technical and Professional, Distance Education and Research programs of the University whereas Male aspirants shall be enrolled only in Distance Education and Research Programs as a external student.
- 2) Special arrangements for Female Students to pursue education in Regular mode as a resident students of the University or may provided Day-boardership to those female students who are resident within 40 Kms Radius of the University Campus and having domicile of Jaipur, Ajmer and Sikar Districts. In Research programs, the female students may enroll as a Regular/External student.
- 3) Fee relaxation/subsidy shall be provided only to female students. Male students are not entitled for any Fee relaxation/Subsidy.
