Sub: Extension of provisional temporary approval of affiliation to **Jyoti Vidyapeeth Women's University, Jaipur, Rajasthan** for three year LL.B as well as five year BA LL.B, five year BBA LL.B and five year B.Com LL.B law courses for the academic year 2019-2020.

Sir,

This is with reference to above mentioned subject regarding extension of provisional approval of affiliation **Jyoti Vidyapeeth Women's University, Jaipur, Rajasthan** which has already applied for extension of approval of affiliation for the academic year 2019-20 and inspection of the Bar Council of India is pending.

The matter relating to colleges similarly placed were considered by the Bar Council of India at its meeting held on 19th May 2019. The resolution passed was as follows:

“RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2019-2020. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently.”

Since your university has given affiliation for the year 2019-2020, you are requested to allow **Jyoti Vidyapeeth Women's University, Jaipur, Rajasthan** to admit students in **three year LL.B** as well as **five year BA LL.B, five year BBA LL.B** and **five year B.Com LL.B** law courses with existing sections for the academic year 2019-2020.

This is for your information and necessary action.



Note - (1) That w.e.f 21.05.2016 the inspection fee for LL.B three year and five year regular course is Rs. 3 lacs for each course and for the Honours course it is Rs. 5 lacs, while the application fee is Rs. 50,000/- and the guarantee amount is Rs. 5 lacs.

Note - (2) your college is requested to pay Rs.10, 000/- towards pending application fee for 2012 and 2016.
