
The matter relating to colleges similarly placed were considered by the Legal Education Committee of the Bar Council of India at its meeting held on 30.4.2017 which was further ratified/ confirmed by the General Council of Bar Council of India on 5th May, 2017. The resolution passed was follows:-

Shree
"RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2017-2018. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently."
